Dear Colleagues,

During the last decades considerable progress has been achieved in the treatment of schizophrenia and in the investigation of the etiology and the pathomechanisms of this disorder. However, many questions concerning e.g. the pathogenesis, early recognition as well as optimal treatment regimens still remain unsolved. In order to answer some of the most urgent questions concerted national or European research actions have been initiated during the last years. Even more progress may be achieved if such networking would be more coordinated and concentrated.

Against this background the German Research Network on Schizophrenia organizes for the first time the European Conference on Schizophrenia Research – Perspectives from European Networks to be held from 26 September, 2007 to 28 September 2007 in Düsseldorf, Germany. One focus of this year's conference is on results from network research in particular concerning the prodromal and first-episode stages of schizophrenia. Several symposia will provide the basis for the scientific exchange on these issues. Moreover, a special workshop shall bring together existing networks in order to mutually learn from each other about research strategies, about experiences in transferring research results into practice as well as about unmet needs, and thus may hopefully offer a chance to promote joint European efforts in schizophrenia research.

Though this focus on network research, all interested colleagues regardless whether they participate in a research network or not are most welcome to present their results and to participate in these sessions.

This year's conference is supposed to launch a series of European conferences on schizophrenia research to be organized every two years in the future. Beyond providing a forum for European network research these conferences shall also address the problem of transferring research into practice. Therefore we want to focus on this challenge in upcoming conferences by not only presenting new research data but also by discussing their impact on practice and to explicitly elaborate take home messages for the practice.

We are proud that our scientific concept gained support of the international (WPA), European (AEP), and national (DGPPN) scientific societies, and sincerely hope they will do so as well in future.

On behalf of the scientific committee I would like to cordially welcome you in Düsseldorf.

Symposia

Symposia focus on new developments on diagnosing schizophrenia, on the main research topics of the GRNS as well as on the neurobiological aspects of the early course of schizophrenia and the neuropsychology of this psychiatric disease. All sessions will be given by distinguished and honourable experts in a specific topic of major interest.

Workshop

The workshop is scheduled for 225 minutes, which includes brief presentations by individual panel members followed by contributions from national networks regarding potential joint European research activities. This session type provides for substantial audience participation and should be highly interactive.

Oral Presentations

Oral Presentation sessions are scheduled for 105 minutes and include a maximum of six speakers chaired by a selected specialist. Each speaker has no more than 17 minutes for his/her presentation including time for discussion.

Guided Poster Tours

All accepted poster abstracts will be presented during the conference. Guided poster tours have been arranged in order to give authors the opportunity to present their findings and to discuss them with the audience. 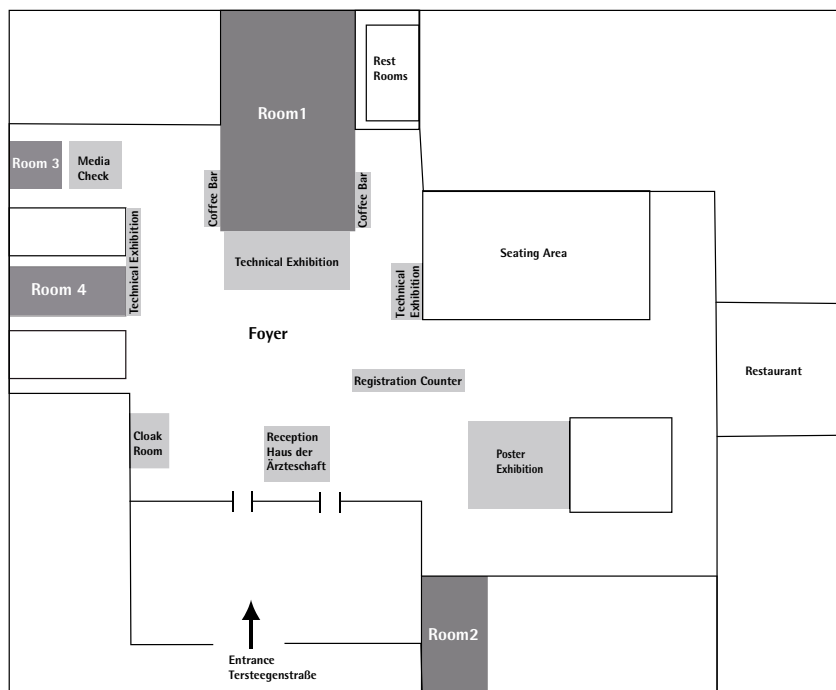
